NOTES:

- 1. Payment of fees alone will not construe automatic approval and/or processing of an application.
- 2. Fees & charges are subject to change without prior notice.
- 3. The urgent fee will NOT be applicable for applications related to agent registration, company liquidation, or re-domiciliation.
- 4. The urgent fee will NOT be applicable for any new incorporation or company registration renewal or company amendment involving more than three shareholders.
- 5. Applications for urgent processing must be submitted before 12:00 noon on the day required for same day service.
- 6. Company incorporations, amendments and renewal applications involving more than three but less than six shareholders/directors, an additional flat fee of AED 275 is applicable. From the sixth shareholders/directors onwards, AED 275 per shareholders/directors will be applicable.
- 7. Courier service will be charged depending on weight of documents and place where it will be couriered to.
- 8. Fines for contraventions of the rules and regulations of RAK ICC shall be applicable as per the standard fines scale which is as follows:

Level of scale	Amount (AED)
Level 1	1000
Level 2	2000
Level 3	5000
Level 4	10000
Level 5	20000

- 9. For changes to share capital- In order to change the par value &/or number of shares with no change in authorised capital, choose amendment type as "Increase in capital-par value with no. of shares" and enter allotting shares as "yes". Applicable fee ref: 43.2.
- 10. Non-specified fees relating to Foundations are as per the company fee schedule.
- 11. For any service requests not specified in the fee schedule a standard fee of AED 1100 applies.
- Where more than 3 activities at the "Activity Group" level are selected an additional charge of AED 550 per activity will be applied.

PENALTIES UPON LATE RENEWAL OF AN ENTITY:

- 1. An entity that is due for registration renewal must be renewed within a time frame of two (2) calendar months (grace period) from the date of expiry of its existing registration.
- 2. An entity applying for registration renewal after the two-calendar month grace period will be subject to a penalty on a graduated scale as per the schedule below:
 - Third month from the date of registration expiry Renewal fee + 10%.
 - o Fourth month from the date of registration expiry Renewal fee + 25%.
 - Fifth month from the date of registration expiry Renewal fee + 50%
 - At the beginning of the sixth month from the date of registration expiry, a strike off notice will be issued to the entity.
 - There will be a one calendar month period before formal strike off in which the entity may make written representations to the Registrar, and/or make the renewal payment including the penalty. If no written representation and/or renewal plus penalty payment is made within six months from the date of registration expiry, the entity will be subject to formal strike off from the register.
- 3. An entity that is struck off from the register can be restored to the register subject to the approval of the Registrar, and upon full payment of all relevant fees and penalties for the period struck off, plus a flat restoration fee of AED 550.
